What are SPIFFs and Commissions?

SPIFFs

Provide your employees with extra incentive to sell certain items. SPIFFs can be either a percentage of the item price, or a flat dollar amount.

Commisions

Offer employees a certain percentage of sales or gross profit using Commissions. Commissionable items will be included in the Performance Pay section of the invoice.



Commissions will be enabled for all items by default. To disable commissions for an item, uncheck the **Commission** box in the Performance Pay settings for that item. Employees will need the permission to view Invoice Profitability if reporting by Gross Profit.

To enable SPIFFs, open the Performance Pay settings for an item and check the **SPIFFs** box. From here, choose either Fixed Dollar Amount or Percentage Amount and set the values you'd like.

To edit SPIFFs or Commissions on an invoice, click the **Edit** button in the Performance Pay section of the invoice. The assigned employee for a SPIFF can be edited, and additional commissionable employees can be added. When editing Commissions, the allocation must total 100%.
